

Bibliographic Presentation Rules

General Standards

In the text : (Surname of author, year)

(Dumas, 2000)

(Dumas, 2000 : 19-22) or (Pool, 2007 : 129 and 142)

Page numbers are shown only in the case of quotes.

In the case of multiple references, separate the different authors by a semicolon.

(Bélanger, 2000 ; Dupuis et al., 2010)

When there are several references from the same author, separate the dates using a semicolon.

(Dumas, 2000 ; 2002)

Document with more than two authors

In the text

List only the first author followed by *et al.*

(Gummerum et al., 2008)

In the bibliography

Enter all authors.

Gummerum, M., M. Keller, M. Takezawa and J. Mata. 2008. » To Give or Not to Give: Children 's and Adolescents' Sharing and Moral Negotiations in Economic Decision Situations, » Child Development, Vol. 79, No. 3, p. 562-576.

The same author had several publications within the same year

Follow the year of publication with a lowercase a, b, c, etc. to differentiate between the publications.

(Tremblay, 2009a)

Presentation of the bibliography for different document types

Book

EndNote Style : Book

Dubet, F. 1994. *Sociologie de l'expérience*, Paris, Le Seuil, « La couleur des idées ».

Collective Book

Barfield, T. (eds.) 1997. *The Dictionary of Anthropology*, Oxford, Blackwell.

Book chapter

EndNote Style : Book section

Clément, S., É. Gagnon et C. Rolland. 2005. « Dynamiques familiales et configurations d'aide », dans *Prendre soin d'un proche âgé. Les enseignements de la France et du Québec*, sous la dir. de S. Clément et J.-P. Lavoie, Ramonville St-Agne, Érès, p. 137-186.

Journal article (print or online)

EndNote Style : Journal Article

A link to the article is not necessary if all the information required to locate it is provided.

Thesis or dissertation

EndNote Style: Thesis

Tremblay, L. 2009. *La décision d'hébergement des personnes âgées au Québec et en France*, thèse de doctorat en administration des affaires, Lyon, Université de Lyon.

Electronic document

EndNote Style : Web Page

Do not include the consultation date unless it is subject to change (i.e. : a wiki).

References in English

Important words in the title are to be in uppercase. Prepositions and articles are lowercase, unless they are the first word of the title. Inside the title, English typography must be respected.

Example: Gummerum, M., M. Keller, M. Takezawa and J. Mata. 2008. » To Give or Not to Give: Children 's and Adolescents' Sharing and Moral Negotiations in Economic Decision Situations, » Child Development, Vol. 79, No. 3, p. 562-576.

Missing information

Without author: move the title of the source instead of the name of the author.

Date of publication unknown: replace date with s.d. Place of publication unknown: replace city by s.l.

No page numbers : replace pages with s.p.

In Press

Do not indicate articles and books that have not yet been published.

Translated work and reissue of classics

In the text

Indicate the date of original publication (see the information on the copyright page)(Berger and Luckmann, 1996 [1968])(Durkheim, 1999 [1922])

In the bibliography

Indicate the original date of publication and the name of the translator. In the case of a reworked edition, indicate which edition it is (2nd ed., For example). All this information appears on the copyright page of the book.

Berger, P. et T. Luckmann. 1996 (1968). *La construction sociale de la réalité*, trad. P. Taminiaux, Paris, Armand Colin.

Durkheim, É. 1999 (1922). *Éducation et sociologie*, Paris, PUF, « Quadrige ».
